Date: January 23, 2017

Regarding lobbyist registration forms, there is nothing that prohibits the electronic registration (including payment) of lobbyists. In fact, Miami-Dade County uses an online registration system. Further, there is nothing in the City Code that requires original lobbyist registration forms be filed. Sec. 2-243(b)(3) of the City Code, does require that the lobbyist “state under oath” certain information. Therefore, the online system should include a statement to that effect and require that the individual check, initial or otherwise note their understanding and acceptance of the fact that the information provide is provide under oath.

Regarding financial disclosure forms, the Miami-Dade Ethics Commission issued an opinion directly on point in 2013, regarding County (municipal) financial disclosure filing, which can be found at: http://ethics.miamidade.gov/library/opinions/2013/rqo_13-02_white.pdf For those required to file State financial disclosure forms, the form only contemplates the filing of originals via U.S. mail and explicitly states that facsimiles are not accepted. Based on this and in the absence of an opinion to the contrary, I conclude that State financial disclosure forms may not be filed electronically.
