The City Attorney opined members of City Boards could also be appointed to the Blue Ribbon Committee established by the City Commission and provide the following additional legal analysis:

Please note, the relevant provision is section 2-59(f) of the City Code, which limits membership on more than one permanent board at one time (section 2-60(b) has similar language). As this is a temporary ad hoc committee (similar to the prior Charter Review Committee), and not a permanent board, the limitation does not apply.
