



# City of Coral Gables Election - April 9, 2019



The City of Coral Gables General Election will be held on **Tuesday, April 09, 2019** between the hours of **7:00 a.m. and 7:00 p.m.** for the following **three** seats:

- **Mayor Seat (Group I) – Two Year Term:** Candidate must live in the City of Coral Gables
- **Commissioner Seat (Group IV) – Four Year Term:** Candidate must live in the City of Coral Gables
- **Commissioner Seat (Group V) – Four Year Term:** Candidate must live in the City of Coral Gables

## NOTICE OF CANDIDACY

Candidate qualifying will begin on **Monday, February 18, 2019 at noon** and end on **Friday, February 22, 2019 at noon**, in the City Clerk’s Office located at Coral Gables City Hall, 405 Biltmore Way, Coral Gables, FL 33134.

**Qualifying Fees: \$200\***

**Assessment Fee: Mayor ..... \$388.70**

**Assessment Fee: Commissioners ... \$315.85**

\*The Qualifying Fee is \$200.00 plus 1.0% of annual salary, with a check drawn from the Campaign Depository. All Candidates must be registered voters and have resided in the City for 12 months prior to the election.

**All Candidates shall be elected by the Voters of the City at Large on a nonpartisan basis.  
If a run-off Election is necessary, it will be held on Tuesday, April 23, 2019.**

## VOTER REGISTRATION

The Registration Books for the **Tuesday, April 9, 2019** Municipal Election will be closed on **March 11, 2019**.

## VOTE-BY-MAIL

The deadline to request a vote-by-mail ballot from Miami-Dade County Elections Department to be mailed is no later than **5 p.m. on April 3, 2019**.
