I have previously opined that the City Attorney's Office is not subject to the travel policy (I would note that the City Attorney is expressly exempt from both the personnel rules and the travel policy). All travel by City Attorneys is to be reviewed and approved by the City Attorney, consistent with the annual budget, and the Procurement Code related to procurements related to legal matters (I would also note that the Deputy City Attorney and Assistant City Attorney are also defined as delegates of the City Attorney under section 2-201(d)). In conducting this travel review as to himself and the attorneys in his office, the City Attorney also considers Bar-related issues and ethics related issues. Ultimately, the City Attorney is responsible for travel by attorneys in his office, and answers to the Commission related to such decisions.

Please note, the Deputy City Attorney and I will be attending two functions in the tri-county area over the next several months, and will be staying on site. I have funds in my budget for both events. The first is the Florida Bar Annual Meeting in Boca Raton. Both the Deputy City Attorney and I serve on statewide boards, which allows us to impact matters of statewide concern and is very prestigious for the City. I serve as the Vice Chair of the Florida Appellate Court Rules Committee and on the Executive Council of the City, County, and Local Government Law section of the Florida Bar. The Deputy City Attorney serves on the statewide Bar Professionalism/Ethics committee. We both also use the opportunity to attend the Annual Meeting to go to evening and morning functions. Accordingly, this is approved for both of us.

Likewise, the Florida Municipal Attorneys Association is having its annual meeting at the Breakers in Palm Beach this year.
