I am writing for the City in response to your request. Section 3-608(A)(1) of the Zoning Code allows for an automatic postponement of an appeal for up to 90 days. It is my understanding that you would like to modify your client's initial request for a 30-day automatic extension so that it would be a request for a 90-day automatic extension. Because the appeal has not been reset or renoticed as of this time, it is my office's view that such a request is permissible and may be granted by the City. Accordingly, I have conferred with City staff, and the 30-day automatic extension previously granted under section 3-608(A)(1) is hereby modified to be a 90-day automatic extension. Any further extension beyond the automatic 90-day period would need to be sought pursuant to section 3-608(A)(2) of the Zoning Code.
