RE: Legal Opinion Regarding Merrick House Project - AIPP fees

Date: September 14, 2016

I have reviewed the definition of Municipal Construction Project on page 3-110 of the Zoning Code, which excludes from the definition "projects to the extent funded from . . . historic related grant funding" or "projects that solely consist of historic restoration . . . ." In my opinion, based on our discussion, this is a historic restoration project related to one of the most historic buildings in Coral Gables (and South Florida as well). The City is also receiving historic related grant funding from the State of Florida. The exclusion therefore applies for two reasons. Finally, I would also note that the funds being used to restore the Merrick House are serving the same purpose as the Art in Public Places Program.

For all of these reasons, the Art in Public Places fee need not be paid for the Merrick House restoration project.

This opinion is issued pursuant to sections 2-201(e)(1) and (8) of the City Code, as well as section 2-702 of the Zoning Code.

Craig - attached are opinions you've done in the past concerning Art in Public Places fees for City Municipal Construction Projects involving the installation of art. I was asked whether the AIPP fees need to be paid for the restoration of the Merrick House project (a City Municipal Construction Project). Remember there are two funds:

Historic Public Art Fund - 1% of the aggregate project value for City Municipal Construction projects to be used for restoration, maintenance and acquisition of historic public art. I don't think that these fees apply since it's a restoration project.

Art Acquisition Fund - 1/2% of City Municipal Construction Projects to be used according to the Master Art Plan. I do think that these fees may apply for the Merrick House Project.

I think we've discussed this before, I just can't remember what the determination was.
