RE: Legal Opinion Regarding Home Occupations

Date: October 19, 2016

I have previously opined on similar issues in CAO 2013-016 and 2013-025. It is my opinion and interpretation that an author may write in her house without converting the residence into a commercial or occupational use. The resident may also have someone come to the house from time to time to transcribe material.

The restriction on home occupations applies where there are business-related impacts, such as where a resident sees "clients/customers at the residence in order to conduct business," or receives "material amounts of business-related deliveries at the residence." See CAO 2013-016. This is not implicated by the situation presented. Also, I would note that writing is protected by the First Amendment. As long as there are not material commercial/business impacts on the surrounding neighborhood related to being an author (i.e., a publishing house could not be run out of a residence), I see no lawful basis for seeking to restrict such activity. Accordingly, an author may write in her residence and conduct activities incidental to such writing (i.e. have someone come by to transcribe from time to time).

This opinion is issued pursuant to section 2-201(e)(1) and (8) of the City Code, as well as section 2-702 of the Zoning Code.
