Respectfully, in my view this is both a *Temple Terrace* and section 6.02 issue. The City has aesthetic and zoning authority regarding all of the residences on Coral Way (and other County roads), including their swales. The City is seeking to remove concrete buttons placed in the swales by residents without permits. This is not a situation where the County has placed or permitted an encroachment in the swale to address a public safety issue, where the balancing of interests test may favor the County (I want to assure you that we have no issue with that.) Our focus is on unlawful buttons, pyramids, etc., which neither the County nor the City has permitted. The City could simply issue citations for these, but has instead approved a program to remove them at the City's own expense (if they are not removed though, then citations would be issued). Ultimately, this is a good and helpful program to the residents, and benefits both the County and the City (as the unlawful encroachments in the swale would no longer be present).

I discussed this with Dennis, and we don't think that the Coral Gables's zoning ordinance trumps our management of our rights-of-way. They are really different areas of law, and additionally, under *Temple Terrace*, the balancing of interest tests may very well favor the County's discretion in the management of its ROW, even where it passes through a municipality.

That said, if there is a way to accommodate this request under the discretion given DTPW in the PW Manual, we agree that it would be best to work together and not have to reach the *Temple Terrace* analysis. Hi Debra. Our Public Works Department informed County Public Works below. I will

make sure they discuss it. This is primarily for the removal of concrete buttons placed by our residents in the swale/right-of-way. They are unlawful and being removed by the City pursuant to the ordinance as a Code Enforcement matter. If they are not removed, the residences would ultimately be cited and have to pay fines.

This is in the nature of an aesthetic/zoning/police power ordinance so can be applied along Coral Way under the Temple Terrace line of cases and section 6.02 of the County Charter. My goal was not to make this a legal issue though, simply to ensure you were informed. I am hopeful that the County will support the effort since the buttons are unlawful. I will make sure that our two departments communicate on this matter. Please call me if you would like to discuss. Best always, Craig

Good afternoon Mr. Guyamier,

As you may know, the City of Coral Gables recently adopted an ordinance amendment prohibiting concrete domes, pyramids, reflectors and other encroachments in the public right-of-way (attached for your reference). We have been notifying residents since April 12, 2016 of their responsibility to remove the encroachments; we plan to finalize the notification period in the next week and will begin citywide removals at our expense by the end of August. Please consider this email notification of our intent to initiate the removal process along Coral Way and potentially other MDC rights-of-way after notifying the residents/properties where the domes remain, and where they are not serving a public purpose. Relatedly, our City Attorney will share this notification with the County's legal team. Please let me know if you have questions or concerns, thank you very much.
