PUBLIC NOTICE - REVISED

Invitation for Bids (IFB) No. 2024-004 FPID No. FM 441640-1-58-01

The City of Coral Gables is soliciting bids for **IFB 2024-004 Transit Stop Improvements for Last Mile.** The contractor must be readily available to provide the services outlined in this solicitation, in accordance with Federal law, regulations, and executive orders; State / Local law and regulations; and Local Agency Program Construction Contract Requirements.

The Invitation for Bids (IFB) package may be downloaded by visiting <u>Infor</u>. Prospective bidders must register with Infor, free-of-charge, in order to download the solicitation. A detailed user guide for the registration process may be downloaded by visiting the Procurement Division <u>Supplier Services</u> webpage.

Any prospective bidder who has received this solicitation by any means other than through Infor must register immediately with Infor to ensure it receives any addendum issued to this solicitation. Failure to acknowledge receipt of an addendum may result in disqualification of bid submitted.

Solicitation responses must be **submitted electronically** through Infor. This includes responses to invitation for bids (IFBS); requests for proposals (RFPS); requests for qualifications (RFQS); and any other formal solicitation.

Any request for additional information or clarification must be received in writing through Infor no later than Friday, May 3, 2024, at 2:00 PM. Bidders should not rely on any representations, statements, or explanations other than those made in this IFB or in any written addendum to this IFB.

Prior to the pre-bid meeting, the name of the companies and meeting participants that plan to attend should be sent to <u>tdonigan@coralgables.com</u>. Attendance is encouraged and recommended as a source of information but is not mandatory.

Bids for IFB-2024-004, FPID No. FM 441640-1-58-01 will be received until 2:00 PM, Tuesday, May 21, 2024. Bids must be submitted electronically through Infor. The responsibility for submitting bids before the stated time and date is solely the responsibility of the Bidder.

Bidders must be pre-qualified by the Florida Department of Transportation (FDOT) in the major work class of road, bridge, or public transportation construction to respond to this solicitation. Pre-qualified certified minority business enterprises (as defined in Florida Statutes §287.0943 and §288.703) and other minority or woman-owned enterprises are encouraged to respond to this solicitation.

Disadvantage Business Enterprise (DBE) is not a requirement of this solicitation however it is encouraged.

Proposers are required to be pre-qualified in all work types required for the Project. The qualification requirements of F.A.C. Chapter 14-22, based on the applicable category of the Project, must be satisfied. The Proposer and/or is Subconsultants/Subcontractors shall, at the time of award and throughout duration of the Contract, be pre-qualified in the following work classes.

If the Contractor chooses to sublet any portion of the Contract, the Contractor must provide a written request to sublet work on the Certification of Sublet Work form developed by the Department for this purpose. With the Engineer's acceptance of the request, the Contractor may sublet a portion of the work, but shall perform with its own organization work amounting to not less than 40% of the total Contract amount.
