As for the one item that was fully executed yesterday, Celeste is adding a column to the memo that provides for the execution date (because the effective date was back in August)... at least this way it should be clear to the Commission that the contract was signed yesterday and they will be notified today.... At yesterday's Commission meeting, an ordinance was passed on second reading that provides for a notice requirement for contracts entered into with consultants for professional serves under Sec. 2-607(24) of the City Code. Please note that for any contract over \$25,000, not including related expenses, the City Manager must now notify the City Commission within 7 days via memorandum.
