ADDRESSING A REAL PROBLEM

- Permit delays are one of the **top complaints** from residents and contractors.
- Staffing shortages and turnover have worsened backlogs.
- Residents deserve options—especially when time is of the essence.



A SIMPLE, OPTIONAL SOLUTION

▶▶ A **voluntary** program for residential and commercial interior remodels.

▶▶ Offers faster turnaround times through a dedicated expedited queue.

▶▶ Powered by city-approved partner reviewers— **not** city employees.

▶▶ Funded by an **optional 15% fee** (on top of the regular permit fee).

vetted.

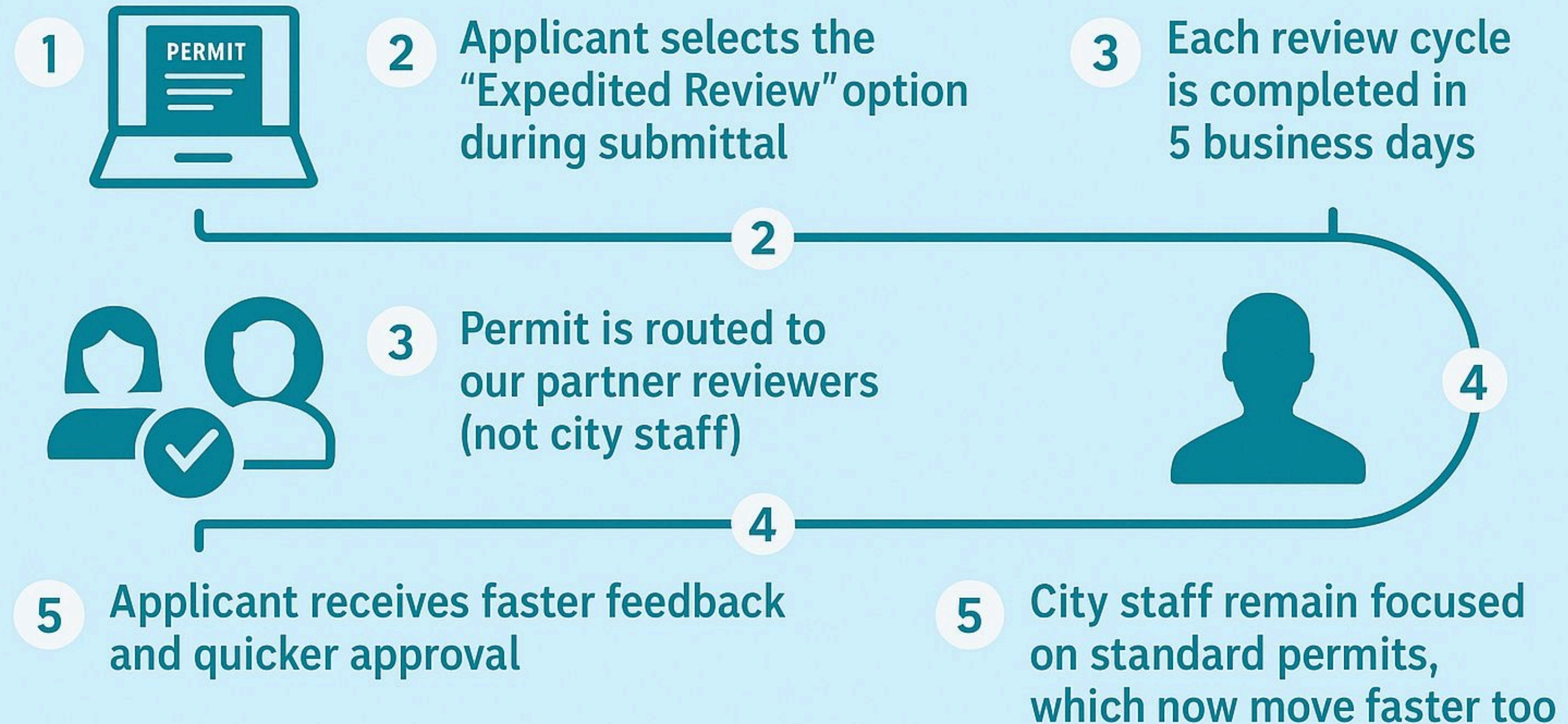
▶ Not mandatory.

Expedited Permit Review Helps All Residents



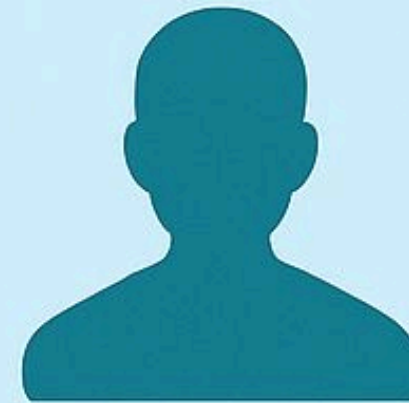
Residents who choose expedited review:

Get permits faster so projects can start sooner



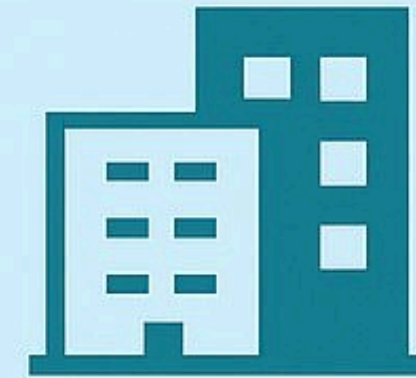
Residents who stick with standard review:

Benefit from shorter wait times since expedited permits go to a separate team



City staff:

Have fewer permits to handle, so they can focus and provide better service



The City overall:

Gets more efficient without hiring more staff or increasing taxes

Bottom line: This program helps everyone—not just those who opt in.



BUILT WITH SAFEGUARDS

▶▶ Partner reviewers are pre-approved professionals already working with the city.

▶▶ Same codes, same standards, same quality as internal city reviews.

▶▶ I voluntarily stopped doing permitting work in Coral Gables a little less than a year ago—not because I had to, but because I chose to avoid even the appearance of conflict.

"It's a private company takeover."	It's a city-managed partnership using professionals already contracted.
