Subject: Request for Formal Legal Opinion on Charter Amendment and AG Opinion Applicability

Dear City Attorney,

I am officially requesting the issuance of a formal written legal opinion by your Office addressing the following three questions:

Is Florida Attorney General James Uthmeier's recent written legal opinion stating that the City of Miami cannot move its elections without first getting voter approval applicable and binding to the City of Coral Gables in light of the City's decision to move its election (by ordinance) without first getting voter approval?

What written protocol does your Office apply to determine which legal opinions from the Florida Attorney General the City should or should not comply with?

What legal authority allows the City to revise the Charter via ordinance to shorten the term of an elected official?

I ask that your Office issue the above-referenced formal written legal opinion no later than June 26, 2025.
