Invitation for Bids (IFB) No. 2025-032

The City of Coral Gables is seeking bids for **Overhead Safety Harness System - IFB 2025-032**. This solicitation consists of the purchase and installation of a fall protection system (overhead safety harness system) for the City of Coral Gables fleet maintenance facility. The contractor must be readily available to provide the services outlined in this solicitation.
