The City of Coral Gables is seeking bids for **Granada Golf Course Rain Shelter Construction - IFB 2026-008**. The project consists of replacing nine (9) rain shelters at the Granada Golf Course, located at 2001 Granada Blvd, Coral Gables FL, 33134, with two City-approved prototype designs
