### Invitation for Bids (IFB) No. 2026-018

The City of Coral Gables is soliciting bids for IFB 2026-018 Park Improvement Project – Cooper Park. The solicitation consists of a comprehensive renovation of Cooper Park, located at 4920 Washington Drive, Coral Gables, FL 33134. The contractor must be readily available to provide the services outlined in this solicitation, in accordance with Federal Emergency Management Agency (FEMA) policies, procedures, and directives; Federal law, regulations, and executive orders; and State / Local law and regulations. A grant application for partial funding has been submitted with the Florida Department of Environmental Protection (FDEP) under application number A-01265. Florida Recreation Development Assistance Program (FRDAP) has recommended this project for fiscal year 26-27.
