Invitation for Bids (IFB) No. 2026-022

The City of Coral Gables is seeking bids for Hard Court Resurfacing – IFB 2026-022. This solicitation consists of resurfacing eight (8) all-weather tennis courts, totaling approximately 57,600 square feet, at the city-owned facility located at 1150 Anastasia Ave, Coral Gables, FL 33134
